That the Board of Administrators (the "Board") of Maplewood Square Council of Co-Owners (the "Association") subject to the approval of a majority of the Board, hereby amends the By-Laws, pursuant to Section 82.102(a)(1) of the Texas Uniform Condominium Act by amending Article Section 5(n)(4), thereto, by adding the following at the end of Paragraph (n)(4):


The Managing Agent or Board of Directors of the Association is permitted to contract for property insurance on the following items within the "Residential Unit" as defined in Article I, Section A(1) of the Declaration:

Fixtures, installations or addition comprising a part of the building within the unfinished interior surfaces of the perimeter walls, floors, and ceilings of individual condominium units initially installed, or replacements thereof, in accordance with the original condominium plans and specifications.

The aforementioned insurance can only be obtained in conjunction with other property insurance and at no additional cost.

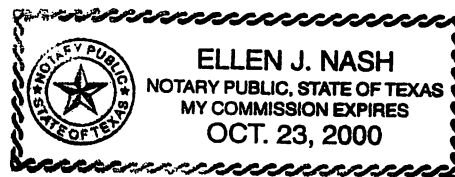
